## REACH + SCIP Confirmation

**REACH Regulation (EC) 1907/2006, Information according to Article 33 Candidate List** The REACH Regulation (EC) No 1907/2006 is the EU Regulation concerning the Registration, Evaluation and Authorisation of Chemicals. It regulates the handling of chemical substances in preparations and articles. REACH is intended to ensure that the use of chemical substances can be traced from from production to end use. Our products are "articles" in the sense of the REACH regulation.

We hereby confirm the following:

- 1. We are a "downstream user" and "importer" within the meaning of REACH. Our products are considered "articles" (not "substances") and as such are not subject to subject to registration.
- 2. With the exception of the substances mentioned under 3, we currently have no information from our suppliers that the products we purchase contain substances on the SVHC candidate list for substances of very high concern in a concentration of >0.1%.
- 3. Articles containing a substance included in the candidate list:

- 4. We have written agreements with all non-EU suppliers to test the materials supplied to us for newly included substances on the SVHC candidate list.
- 5. Our EU suppliers are obliged to inform us without being asked and without delay if the products they deliver contain a SVHC substance above 0.1% is contained.

We comply with the obligation according to Article 33 of the REACH Regulation and inform our customers immediately if, according to new knowledge, "Substances of Very High substances of very high concern" from the SVHC candidate list are contained in our products. 0.1% are contained in our products.

## Notification SCIP database

Since January 2021 every manufacturer of products has to register them in the SCIP database if they contain dangerous substances according to REACH Regulation (EC) 1907/2006. In concrete terms, this means that according to the REACH regulation, manufacturers and importers are obliged to check their products for substances on the SVHC candidate list. We confirm compliance with the notification obligation according to the REACH Regulation for all articles when the mass percentage threshold for all currently listed SVHC substances of 0.1% is exceeded at the ECHA by entering them in the SCIP database, which will be accessible to all from February 2021.
